5. <u>Correspondence</u>

Board members received information regarding the upcoming School Board Association meeting to be held on November 14, 2019 in Plattsburgh. Reservation need to be made by November 1, 2019.

6. Superintendents' Report

Mr. Boucher advised the board that the District is having a NYS Comptrollers' Audit. Auditing payroll here at Putnam and then will be going to FEH BOCES in Malone. NYS Retirement requires a "Standard Work Day" which will be discussed later.

7. District Issues/Operations & Finance

- 7.1 Upon recommendation of Mr. Boucher, Beth McIntyre made a motion and seconded by Carolyn Andersen to appoint Yvonne Fuller as the district Occupational Therapist effective 10/3/19 at a rate of \$75.00 per hour. Motion carried 4-0
- 7.2 Mr. Boucher advised the Board that the district is in receipt of a letter from the Washington County Board of Elections advising the district that they will be unable to provide the school with a voting machine for May 2020 school election due to the many changes made by New York State to the preparation and follow-up now required for Elections.
